## **EQUITY MARKET SUMMARY**

The market kicked off the week, trading 55,000 shares across 4 stocks, with a worth of P102,000. BTCL led the trades, in terms of volumes moved, with 45,000 shares trading worth P39,500. Demand for the stock is still on the low side, unfortunately posing a threat to the stability of the share price. Letshego's financial results published today, were relatively on the flat side, as was expected. The Group's operating income went up by 6%, which translated from among others, growth in the the Group's interest income. The top three contributors to the operating income, were the Botswana operations, Namibia and West Africa (which includes Nigeria and Ghana). All inclusive, the group's profit after tax was in line with the prior year at P364,000. The Group has also declared a dividend of 4.3 thebe for each share, payable at the end of the month, i.e. September

27th, to be exact, after the deduction of withholding tax.
